\$40 PER ITEM + SHIPPING/INSURANCE IF SHIPPING THEM TO OTHER FFL DEALERS. ITEMS WILL SHIP AFTER 3 BUSINESS DAYS FROM RECEIVING SHIPPING INSTRUCTIONS AND ALL FFL LICENSING DOCUMENTS. SHIPPING IS ONLY AVAILABLE TO LICENSED FFL DEALERS.

\$60 PER ITEM + \$25 BACK ROUND CHECK PER BUYER IF TRANSFERRING LOCALLY AND CONDUCTING CALIFORNIA BACKGROUND CHECKS.
